Constitution of the platform of European Groupings of Territorial Cooperation (EGTC)

The Committee of the Regions will constitute the platform of European Groupings of Territorial Cooperation (EGTC).

This EGTC Platform will integrate the political and technical representatives of all the existing EGTCs, EGTCs under constitution and members of the Expert Group. Associations and other experts and stakeholders are invited to participate.

Mission:

The EGTC platform will have the following mission:

- a) Monitoring the adoption and implementation of the EGTC provisions at EU and national level;
- b) Facilitating the exchange of experiences on the establishment of EGTCs at territorial level and sharing knowledge of best practices in the field;
- c) Promoting the EGTC as a tool for territorial cohesion and give visibility to the existing EGTCs, notably among the EU Institutions, the national and sub-national administrations;
- d) Improving communication on EGTC opportunities and challenges at territorial level;
- e) Identifying the potential use of EGTC as a tool for cohesive territorial development;
- f) Supporting the consultative works of the CoR by providing factual information about multilevel governance and cross-border aspects of the EU legislation and policies.

Membership:

The platform will include the political and technical representatives of all the existing EGTC and EGTCs under constitution, members of the Expert Group, associations and other stakeholders.

Governance:

- a) The existing EGTC and the active members of the Expert Group will be automatically entitled to be partners of the Platform. The CoR will invite the EGTCs under constitution, and targeted experts and stakeholders (like INTERACT and associations).
- b) The Chairman of the Commission COTER will act as political co-ordinator of the EGTC Platform and will report regularly to the Commission COTER and to the Bureau.
- c) The ordinary administration of the EGTC Platform will be run by the CoR.

Online support:

The CoR will provide online support to the Platform: In the coming months, the EGTC web portal will be reorganized and new sections will be created in order to make it more interactive and to develop a real common consultative platform and to support the Platform.

- A common consultative platform (web forum) will enable representatives of the existing EGTCs and those under preparation, EGTC experts, and stakeholders to exchange their experiences and good practices.
- Each of the EGTCs will have a micro web page (microsite)¹ where they can provide their news and other contents.

Budget:

The functioning of the Platform will not imply additional expenses to those already foreseen in the budget of 2011 and 2012 for the ordinary EGTC activities of the CoR.

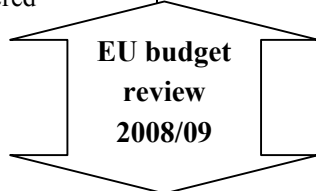
